#### TOUR: THE J. PAUL GETTY MUSEUM

The building is a re-creation of an ancient Roman country house, the Villa dei Papiri. The gardens include the same types of trees, flowers, shrubs, and herbs that might have been growing 2000 years ago in the Villa dei Papiri. The bronze statues in the garden are modern castings of ones unearthed during the eighteenth century.

The collection of Greek and Roman antiquities is considered one of the three most important in the United States. All major schools of western European art from the late 13th to the early 20th centuries are represented in this collection. This collection features furniture, carpets, tapestries, clocks, chandeliers and small decorative items made for French nobility and the Royal household from the early years of the reign of Louis XIV to the age of Napoleon (1670-1815).

## Suggested By-Law Change:

Proposed and approved by Council, membership will vote at the annual meeting.

Add to page 5—Section 2:

e. *Interim Member*—A dental school graduate who has been selected to receive the Academy's Gold Foil Achievement Certificate with a coincident one year's membership.

f. *Student Member*—A dental school undergraduate who demonstrates an interest in the Academy and its objectives shall be eligible for temporary membership prior to graduation.

Add to page 5—Section 3:

e. *Interim Member*—Those recipients of the Gold Foil Achievement Certificate shall have been identified by the Education Committee and awarded a one year membership without formal application. They will have to apply in standard form for Associate Membership at the expiration of this status.

f. *Student Member*—For Student Membership, the method of application will be similar to that of Active Membership. Signatures of two Active members will be required, a nominal fee to be determined by the Board of Directors must accompany the application, and approval may be granted by the Secretary-treasurer in view of the limited time eligibility of the applicant. The student will have to apply for Associate Membership following standard procedure upon graduation, if not designated as an Interim Member.

were graduate students—Drs. Bruce Matis, Adrian Porte, Silvio Monteiro and Halla Sigurjons.
