Minutes of Board Meeting — February 1990

The Executive Board of the American Academy of Gold Foil Operators met on Wednesday, February 6, 1990, in the Consulate Rooms I-III of the Westin Hotel, Chicago, with President Dr. William Harris presiding.

The minutes of the October 1989 meeting were presented as they appeared in the Gold Leaf. They were accepted with one correction—the names of Dr. Daniel D. Saucy, Salem, Oregon, and Dr. K. Birgitta Brown, Lincoln, Nebraska, were added to the list of associate members.

REPORT OF BOARD MEMBERS:

Dr. Michael A. Cochran — Program Chairman

It was reported that the topic would be "Direct Gold From Different View Points." Most speakers and plans are complete.

Dr. Alfred C. Heston — Clinic Chairman

The idea of the written critique for each person operating at the annual meeting was discussed by the group. The final decision was that each clinical chairman should have the privilege of making that decision for his program. It was suggested that the clinicians be notified in advance of the meeting if the written critique was being used. It was also decided that each participant would be presented a certificate for his participation. The chairman was reminded that each operator must be a member in good standing in the American Academy of Gold Foil Operators and must register for the meeting. Dr. Bob Keene is assisting in securing operators on the local level for the Boston meeting.

TREASURER'S REPORT:

Dr. Nelson W. Rupp, Secretary-Treasurer

It was noted that the operating account ended the 1989 year with a sizeable surplus. The same amount remains in investments with interest being used for expenses. The 1990-91 budget was presented. The Financial Statement for 1989 and the budget were approved as read.

COMMITTEE REPORTS:

Journal:

Dr. David Bales, Editor

Reported that Volume 14, 1989 consisted of 224 pages. 1990 publication will consist of six issues rather than four. The planned schedule is to mail the Journal the last week of January, March, May, July, September, and October.

Dr. Bales reminded the Board that he is requesting a replacement for his position as editor by January 1992.

Dr. J. Martin Anderson, Managing Editor

Dr. Anderson presented Financial Summary of Volumes 11-14. It was brought to the attention of the Board that the subscription from the AAGFO members had dropped. It was determined that many were not including their subscription with payment of dues. It was reaffirmed that the Foil Academy By-Laws state that each member must subscribe to the Journal. This correction will be made with the 1990 dues notices.

These reports were approved and a vote of appreciation was extended to Dr. Bales and Dr. Anderson for their exemplary efforts.

Literature and Research — Dr. Timothy Carlson, Chairman

It was announced that the Direct Gold Reference Book had been very well received. The Committee is now considering placing the same references on

computer disks. They would also like to add to these references teaching manuals from the various Dental Universities. The President commended this committee for their active interest.

Nominating — Dr. Perry Dungey, Chairman

This group is working but not yet ready to make a report.

Membership — Dr. Don Benson, Chairman

Report presented by Assistant to Secretary. 215 members paid dues by February 1, 1990.

Members were urged to get application in by August 1 so that they may be processed by the time of the fall meeting.

Public Relations — Dr. David Bridgeman, Chairman

Efforts to get local publicity for meetings and Study Clubs continue to be a primary goal for this body. Plans are on the agenda for seeking the possibility of having a table clinic promoting the use of Direct Gold at the Operative Academy Meeting. It was also suggested that the committee consider promoting the use of the rubber dam as a barrier technique.

Necrology — Dr. William J. Roberts, Chairman

No report at this time.

Education and Study Clubs — Dr. Glen Birkitt, Chairman

In the absence of Dr. Birkitt, the President announced to the Board that a display promoting Study Clubs would be on the mezzanine of the Westin on Thursday, February 7, and Friday, February 8. Results from the questionnaires that went out to members in December are being compiled and edited for publication in the 1990-91 Roster.

Achievement Award — Dr. Ronald K. Harris, Chairman

Reported this committee working, but has no report at this time.

Distinguished Member — Dr. Jose Medina, Chairman

This group announced that guidelines are being compiled for selecting nominees for the award for Distinguished Member. The committee is not prepared to make a report at this time, but they are making progress with their plans.

Direct Gold Alive and Well in Indiana

After a two year break, the course in Direct Gold Technique was again held at Indiana University School of Dentistry May 22-25. Typically it is programmed for eight Basic and four Advanced enrollees, but this time, there was more interest in the advanced course so the numbers were reversed. There were to be seven Advanced and four Basic participants until the last minute, when two of the Advanced registrants had to withdraw. The course consists of introductory lectures, lab exercises and clinical procedures, with greater clinical emphasis and more demanding procedures for the Advanced group.

Enrollees this year were Drs. Howard Paige (NYU), Henry Young (Meharry), Jackson Linger (U. of Michigan), and Ray Phelan (U.S. Army - prosthodontist) in the Basic course. Those in the Advanced course were Drs. Eric Morrison (private practice - Bethesda, MD), R. Bruce Walter (Seattle, WA - private practice and U. of

Wash), Bud Phelan (private practice - Concord, NH), Edward Welsh (Med. Univ. of S. Carolina), and GianCarlo Gallo (private practice - Alba, Italy). It was a good mix of educators and practitioners, and a lot of good ideas and stories were exchanged during the week.

Heading the Advanced course were Mel Lund and Lloyd Baum, and doing the Basic plus assisting where needed were Ron Harris, Mike Cochran, Tim Carlson and George Willis. There was a lot of "one-on-one" activity and some of the participants had a fair amount of previous experience.

Enthusiasm was high and patients all showed up, thanks in no small part to the efforts of assistant Judy Young. There are already some requests for a repeat in 1991, but due to a planned trip by the Foil Academy to Italy next summer, it might be deferred.

About The Region

The Region of Liguria lies between the Appenine mountains and the Ligurian Sea. It is a region of rich green vegetation, multicolored frescoed houses.

Genoa is the capital of the region, and divides the Ligurian Riviera into east and west areas.

The Ligurians were merchants back into the 5th, and 6th centuries B.C., having close relationships with the Carthaginians. They aided Hannibal in his war against Rome, and Genoa was destroyed in the fighting. Following the battle of Zama in 203 B.C. the Romans rebuilt the city as a token of gratitude.

The region remained important for trading purposes, and suffered raids by marauding Arabs, conquest by Byzantynes, by the Longobard King Rotair, and later by the Franks who introduced feudalism into the area.

In 1796 the region was invaded by Napoleon's troops which state of affairs remained until 1815 when the region was assigned to Piedmont.



Chicago, Illinois — February 1990

The American Academy of Operative Dentistry held its annual meeting on February 7, 1990 and celebrated the awarding of certification documents to six new members: Dr. Olan D. Parr, Jr., United States Army; Dr. Clyde L. Roggenkamp, United States Air Force; and Drs. Henry A. St. Germain, Jr. Steve Wallace, Francis J. Robertello, and Richard C. Vinci, United States Navy. Dr. Parr is the first member of the United States Army Dental Corps. to achieve board status in operative dentistry.

Board Certification is a form of recognition in Dentistry for distinction as accomplished by successfully passing a three part examination in Restorative Dentistry. Over a period of three or more

years the candidate takes a written exam, an oral exam on completed clinical cases and then takes a two-day clinical examination.

The new inductees represent the most recent in a group of twenty-three dentists throughout the world who have been so honored by the American Board.

The certification system was established by the American Academy of Operative Dentistry in 1981 to promote the pursuit of excellence in dentistry in the practice, education and research in operative dentistry. As of this time well over thirty dentists from around the world have begun the certification process.


